

FINAL PUBLIC NOTICE

The Federal Emergency Management Agency (FEMA) has received the subgrant application for the Hendry County School District's Clewiston High School and Cane Field facility repairs due to damages in Hurricane Irma (DR-4337-FL PW 07534). Pursuant to Executive Order 11988 and 44 CFR Part 9.12, final notice is hereby given of FEMA's intent to provide funding for this project under the Public Assistance (PA) Program.

An initial disaster-wide Public Notice was published October 06, 2017 for Hurricane Irma. Comments and other information received were fully evaluated by FEMA along with evaluation of social, economic, environmental, and safety considerations. This notice serves as a project-specific final notice for FEMA's funding action located within the floodplain.

Funding for the proposed project will be conditional upon compliance with all applicable federal, tribal, state and local laws, regulations, floodplain standards, permit requirements and conditions. This action complies with the National Flood Insurance Program (NFIP) requirements.

- Floodplain:** Portions of the project are located in the AE Zone otherwise known as the area of 100-year flooding, per Hendry County FIRM Panels #s 12099C0425F and 12099C0225 dated 10/05/2017.
- Proposed Work and Purpose:** The Hendry County School District has or will repair damaged perimeter fencing surrounding Clewiston High School and the press box, field house roof, gutters and downspouts, batting cage, scoreboard, stadium lighting, steps, handrails and cable anchors located at Clewiston High School Cane Field to pre-disaster design, function and capacity within existing facility footprints. No mitigation is included in this project.
- Project Alternatives:** The alternative that has been considered is the no action alternative. This alternative is not feasible as it would adversely impact social and economic resources for the community. Alternate locations were not considered as the damaged elements are part of and integral to a larger high school facilities complex and athletic field and stadium. The facilities also provide open space uses for recreation and extracurricular activities.
